Broadford & Strath Community Company is a Scottish Registered Charity (SC034829) and Registered Company Limited by Guarantee (SC034829). The Company was formed in 2003, evolving from the Broadford Environmental Development Group.

Our vision is to create a strong, self-sufficient, inclusive and eco-friendly community in Broadford & Strath, south Skye, Our mission is to improve the natural and built environment of Broadford & Strath, and ensure it is a desirable place in which current and future generations enjoy living, working and spending time.

We work with our community to develop and deliver a range of projects to improve amenities. support health & well-being and enhance our environment. These include community allotments, outdoor learning, horticultural therapy, tree nursery, community woodland, community garden and an extensive paths network. ### **Director main duties:**

- Attending board meetings (monthly, evenings). Meetings normally take place in Broadford but may be attended via videoconferencing
- Contributing to overseeing the strategic direction of the company
- Ensuring the company complies with its legal obligations
- Providing support for staff
- Representing the company as required at events, conferences, etc.

Directors are encouraged to focus on a specific project or area. depending on their skill set and interests. Projects include environmental/biodiversity initiatives, woodland development, buildings and education. Areas include staff line management, finance, or fundraising.

## Skills, experience and personal qualities:

We are looking for people who will bring energy, enthusiasm and commitment to the role, and who will broaden the diversity of thinking on our board. You will have the ability to think creatively and strategically, exercise good, independent judgement, and work effectively as a board member. You will work well in a team, have good written and verbal communication skills, and be computer-literate.

You do not need previous governance experience – we will provide a full induction and training. A PVG Disclosure is required for all Directors, which we will arrange.
